EXCLUSIVE REMEDY

Your Babcock-Davis product is warranted to be free from defects in manufacturing, materials, factory finishes and workmanship. This Limited Warranty is made as of the original date of product purchase and is not a warranty of future performance.

If a covered defect is reported within **FIVE (5)** years from the date your Babcock-Davis product was originally shipped, and otherwise in accordance with the terms of the Limited Warranty, Babcock-Davis will, at its option, repair or replace the product or component, or refund the price paid for the defective product or component. Removal, installation, finishing, refinishing, and disposal costs and services are not included.
